Rashid has interests in furthering partnerships that support international human rights law and their rollout of policies in the Region.

### 2. Purna Chandra Misra

Director, Indian Institute of Youth & Development (IIYD), Odisha, India, and Regional Committee Member of Freshwater Action Network South Asia (FANSA).



PC Misra believes that the (human) rights-based approach (HRBA) adopted elsewhere in the world can be replicated in South Asia, giving a gradual shifting from the service delivery approach to the HRBA.

## Our 2<sup>nd</sup> AGM

HR2W has its second Annual General Meeting on 14<sup>th</sup> June at 14h-16h CET. Members, please mark the date in your diaries. You will shortly be receiving instructions and background information for registration and voting by email.

The agenda will include a review of current activities, and budgets, plus an introduction to the new Board nominees. We are extremely lucky to have four excellent candidates from three continents, including the four nominees listed here.

This year, as we complete a two-year cycle, we also need to re-elect all existing board members. We are expanding the Board to add three new positions so there will be a total of ten Board Members elected. We encourage you to attend in person for the voting. If you are unable to join live, then you are also entitled to vote by proxy (details to follow in the email package that will follow this month).

## Stakeholder Engagement and People-first PPPs

HR2W has supported the UNECE programme to encourage sustainable development through the People-first PPP programme. The outcome, adopted by member States is an evaluation tool that provides a checklist for PPPs to consider all the SDGs through a methodology that includes five outcomes of 1. Access and equity, 2. Economic Sustainability, 3. Environmental Resilience, 4. Replicability, and 5. Stakeholder Engagement.

Leading outcome 5, Amanda Loeffen has included the HRBA in the Pf-PPP tool, and written a guideline for stakeholder engagement. More information can be found on the UNECE website, where the tool is free to use:

## Groundwater and Human Rights

The UN-Water theme this year is on Groundwater, and “making the invisible visible”. It is an opportunity to link the human rights to water and sanitation with groundwater, and also with the Right to a Healthy Environment.

For **World Water Day**, we hosted an interview with David Boyd, the Special Rapporteur on the right to a healthy environment, and experts Jenny Gronwall (SIWI) and Kirstin Danert.

This exploratory discussion helped to link groundwater with a range of human rights, and the important role that groundwater has in securing access to drinking water for a huge percentage of the global population. It reinforces the need to protect our ecosystems for the long-term security of our water supplies.

## Policy Paper on Human Rights Indicators

The research in Mexico and Kenya culminated with a good understanding of the methodology for developing human rights indicators. This information has been shared through an easily comprehended policy, in collaboration with IWRA, the Kenya National Commission on Human Rights, and SDC.

We are actively discussing options for expanding this methodology to other countries, and to seek ways to scale the approach for a more regional approach.

## Open Eyes and Ears to Youth

The HR2W Youth Platform was established a year ago to act as a support for the numerous youth networks on water that already exist. Imanol and Gussie started the process by interviewing youth members, conducting online interviews (on YouTube) and developing a declaration, to find out how our platform could be complementary to other youth networks.

This February, in a workshop-style webinar, Nada and Isa continued the programme in an active webinar discussion with leaders of youth networks and advisors from GIZ and the Women for Water Programme. They highlighted the challenges and needs of young people working in the water sector.

## Human right to a clean, healthy, and sustainable environment

This human right was adopted on 8 October 2021, when the UN Human Rights Council adopted resolution 48/13 recognizing that a clean, healthy and sustainable environment is a human right.

An estimated one in six premature deaths are caused by pollution. Tens of millions of people are displaced each year by climate change. Biodiversity loss threatens the collapse of entire ecosystems<sup>1</sup>.
