<u>Vhat do we mean by innovation?</u>



Amanda Loeffen is the CEO of Human Right 2 Water, and an experienced general manager and business development executive in water, energy and sustainable development, working on projects in Africa, Latin America, and South Asia, plus leading research in water and environmental law. Her goal is to provide sustainable solutions based on human rights to improve water governance worldwide. She leads a team of water governance experts to encourage law and policy reform. Current research projects include a global study on Resilience to Climate Emergencies, the link between the healthy environment and water, and the development of Human Rights Indicators. She leads the UNECE People-First PPP Stakeholder Engagement subgroup to realise benchmarks for developing human rights-based approaches, and she is currently on the steering committee of AGUASAN, co-chair of the Water and Climate Coalition, VP of the Water 4 All Stakeholder Engagement Board, and on the Strategic Advisory Committee of the World Water Quality Alliance. Previously, as CEO of a project management company in New Zealand, Amanda delivered environmental resource consent with stakeholder engagement for a community water infrastructure scheme for irrigation and hydro-generation.



**Mr. Dhesigen Naidoo** is a World Bank Senior Advisor of Adaptation to the South African Presidential Climate Commission and Senior Research Associate at the Institute for Security Studies Africa. He is a leader, a scientist and an activist for positive social change. He is also a member of the Presidential Climate Change Commission, President of the global NCO Human Right 2 Water and a Founding Member of the Water Policy Group. He has led the Water Research Commission (WRC), South Africa's dedicated national Water and Sanitation Innovation, Research and Development Agency for 10 years. He has previously served in senior positions in the South African national government and South African universities having begun his career as a medical scientist in a specialist children's hospital. He is a Councillor of the South African National Advisory Council on Innovation (NACI) and a Fellow of the Mapangubwe Institute for Strategic Reflection (MISTRA). He counts his lovely wife and beautiful children as both his primary source of inspiration and vanguard of his humility



**Ailén Flores** was born in 1998 in Luján, Buenos Aires province, Argentina. She achieved a Degree in Environmental Information from the Universidad Nacional de Luján (UNLu) (2017-2021). She is studying PhD in Social Sciences at the Universidad Nacional de Luján. She achieved a Consejo Nacional de Investigaciones Científicas y Técnicas Doctoral Fellow (2022-2027), academic membership Instituto de Ecología y Desarrollo Sustentable (INEDES-UNLu).
